Round table discussion on "Keys for a successful delivery of the Lisbon Strategy"

As shown by Commission's annual progress reports on the Lisbon Strategy, the pace and depth of reforms varies widely across the Union. Successfully delivering structural reforms depends on many factors. Clearly, the extent and depth of public and political support behind an ambitious reform agenda is a key factor.

Raising ownership and better communicating around reforms have been identified by National Lisbon Coordinators as areas where progress needs to be achieved within the Lisbon Strategy after 2010 to improve results. This includes active involvement of national legislative bodies, early involvement of social partners and other stakeholders in the reform process; and the active participation of regional and local actors (e.g. by using the Structural funds instruments in support of Lisbon reforms). Another success-factor concerns the effective progress-monitoring of reforms' implementation.

A panel of policy-makers, stakeholders and national coordinators will have a debate on which are the keys to a successful delivery of reforms notably by sharing views and experiences in the light of the economic recovery. Thus, short presentations of concrete experiences or examples of good practice will be followed by an interactive debate.
