

## RESOLUTION

## OF THE GOVERNMENT OF THE CZECH REPUBLIC

## No. 1374 of 23 December 2020 on the Amendment of Emergency Measures

In relation to Government Resolution No. 957 of 30 September 2020, whereby the Government, in line with Articles 5 and 6 of Constitutional Act No. 110/1998 Coll., on the Security of the Czech Republic, declared a state of emergency for the Czech Republic, due to a threat to health in relation to the documented occurrence of a coronavirus (designated as SARS CoV-2) in the Czech Republic, and in line with Section 5(a) to (e) and Section 6 of Act No. 240/2000 Coll., on Crisis Management and amending certain acts (the Crisis Act), as amended, to address the current emergency situation, the government has decided to adopt emergency measures, pursuant to Section 5(1)(b) to (e) and Section 6(1)(b) of the Crisis Act.

Effective as of 12:00 a.m. on 24 December 2020, the Government

- I. amends the period of effectiveness of:
  - 1. Government Resolution No. 1202 of 20 November 2020, promulgated under No. 478/2020 Coll., as amended by Government Resolution No. 1295 of 10 December 2020, promulgated under No. 522/2020 Coll.
  - Government Resolution No. 1332 of 14 December 2020, promulgated under No. 533/2020 Coll., as amended by Government Resolution No. 1341 of 17 December 2020, promulgated under No. 564/2020 Coll.
  - 3. Government Resolution No. 1334 of 14 December 2020, promulgated under No. 535/2020 Coll., as amended by Government Resolution No. 1341 of 17 December 2020, promulgated under No. 564/2020 Coll.
  - 4. points I and II of Government Resolution No. 1335 of 14 December 2020, promulgated under No. 536/2020 Coll.,

in such a way that their period of effectiveness is extended until 11:59 p.m. on 26 December 2020;

- **II. amends** the period of effectiveness of Government Resolution No. 1264 of 30 November 2020, promulgated under No. 500/2020 Coll., as amended by Government Resolution No. 1295 of 10 December 2020, promulgated under No. 522/2020 Coll., in such a way that its period of effectiveness is extended until 11:59 p.m. on 10 January 2021;
- **III. amends** Government Resolution No. 1332 of 14 December 2020, promulgated under No. 533/2020 Coll., as amended by Government Resolution No. 1341 of 17 December 2020, promulgated under No. 564/2020 Coll., in such a way that point I/5 now reads:
  - "5. retail sales and the sales and provision of services in shops on public holidays and other holidays for the whole day, on 24 December 2020, however, only between the hours of 12:00 noon and 11:59 p.m., and on other days from 11:00 p.m. to 4:59 a.m., where this prohibition does not apply to activities that are not trades in accordance with the Trades Licensing Act or to the operation
    - a) of petrol stations selling fuels and lubricants;
    - b) pharmacies;
    - c) shops in places with a high concentration of passengers at airports, railway stations and bus stations;
    - d) shops at healthcare facilities;
    - e) outlets for catering services to an extent in accordance with point I/1;

- f) rental and servicing points for sporting equipment, ski schools, information centres, car parks and multi-storey car parks in ski resorts,
- g) ski lifts;".
- **IV. amends** Government Resolution No. 1334 of 14 December 2020, promulgated under No. 535/2020 Coll., as amended by Government Resolution No. 1341 of 17 December 2020, promulgated under No. 564/2020 Coll., in such a way that:
- a new point I/7 is inserted after point I/6, this new point reading as follows:
  "7. trips and gatherings organised by a church or religious society and participation in them from 11:00 p.m. on 24 December 2020 until 1:59 a.m. on 25 December 2020,". The former point I/7 will be re-numbered point I/8.
- 2. in point IV., sub-point b) will read:
  - "b) gatherings organised by a church or religious society in a church or in another room intended for religious ceremonies cannot be attended by more persons than corresponds to the occupancy of at most 20% of the seats, where the attendees, with the exception of the persons conducting or organising the ceremony, sit for most of the time on seats, comply, with the exception of members of the same household, with distancing of at least 2 metres between attendees sitting in one row of seats, before entering the indoor space they disinfect their hands, hands are not shaken when greeting the room and as a part of the gathering there is no mass singing, with the exception of cases when the singers or choir are separated from the other participants in such a gathering in such a way as to prevent the spread of droplets;".
