

What is the RPC?


Regulatory Policy Committee



- From April 2012, 8 Committee members:
 - Chairman (business experience)
 - 2 professional economists
 - 5 generalists, including business and trades union backgrounds includes small business expertise
- Supported by a secretariat of civil servants, including a mix of policy officials and economists



Our role in the UK system





January 2011- present

- All RPC Opinions have included a Red, Amber or Green flag;
 - RED: The IA is 'Not Fit for Purpose'. Major concerns over the quality of the evidence and analysis and overall quality of the IA that *must/need to* be addressed.
 - AMBER: The IA is 'Fit for Purpose'. However, we will set out areas of concern with the IA which *should* be resolved so as to improve its contribution to the final decision made.
 - GREEN: The IA is 'Fit for Purpose'. No significant concerns or some minor issues where the IA that *could* be improved to deliver greater clarity or to aid understanding.
- If departments proceed with a Red, at either consultation or final stage, that RPC Opinion will be published



Our role in 'One-in, One-out'

- Validating that a department has correctly recognised the direction of its regulatory proposal – an 'IN' or an 'OUT'
- Validating that the size of the 'IN' or 'OUT' being claimed is robust and credible and in accordance with the OIOO Methodology
 - If an 'OUT' is overestimated, business will be exposed to greater regulatory burdens in the future than it *actually* has had removed from it today
 - If an 'IN' is underestimated, business will receive a smaller benefit in the future to compensate for the burden now



Our 7 Recommendations

- Identified as integral steps in producing a high quality IA
 - 1. Don't presume regulation is the answer
 - 2. Take time and effort to consider all options
 - 3. Make sure you have substantive evidence
 - 4. Produce reliable estimates of the costs and benefits
 - 5. Assess non-monetary impacts thoroughly
 - 6. Explain and present results clearly
 - 7. Understand the real cost to business of regulation
- Aimed at strengthening the quality of analysis and use of evidence in the policy-making process



2011 Report - Headline Findings

<u>2010 – 186 IAs Reviewed</u>


- 2010 56% Fit for purpose
- Nearly 1 in 2 Not Fit for purpose

<u>2011 – 465 IAs Reviewed</u>

- 2011 first six months 69% Fit for purpose
- 2011 last six months 75% Fit for purpose
- 2011 Overall **72%**
- But still means 1 in 4 Not Fit for purpose
- 31% of IAs received Green Rating

<u>A Wider Perspective</u>

- One-In, One-Out
 - Clearly putting pressure on Whitehall Departments;
 - Level of Outs growing
 - Expect to see more resulting from Red Tape Challenges
- Scope of OIOO
 - Scope set by Ministers
 - Clear it does not cover all regulation that impacts on business (European, Independent Regulators)
- Transparency
 - Publication of our Opinions
- RPC now one of five Independent bodies within Europe and have close relationships with them

European regulation



Scrutiny of IAs of measures with European origin

- The RPC considers IAs to implement EU directives and regulations.
- OIOO excludes EU measures. Particular attention to "gold-plating".

Wider engagement with Europe

- The RPC works closely with sister organisations in the Netherlands (ACTAL), Sweden (Regelrådet) and Germany (NKR) to champion better regulation at the European level. A similar independent watchdog has also recently been established in Czech Republic.
 - Production and presentations of a joint paper calling for improvement (new programme, net targets, independent body, IA process)
 - Pressing the Commission to publish the net costs to business
- Member of the EU High Level Group of Independent Stakeholders on Administrative Burdens
 - Extension of the mandate to end 2014
 - New Terms of Reference being discussed

<u>Summary</u>



- Independent scrutiny is playing a key role in improving the quality of the evidence and analysis on which Ministers make decisions.
- Departments have raised their game in 2011 with a significant improvement compared to 2010.
- But 1 in 4 still Not Fit for Purpose important that overall performance improves again in 2012.
- Want to see more Green rated IAs (highest quality) in 2012.
- RPC keen for greater transparency of our work.
- RPC became Advisory Non-Departmental Public Body in April 2012.
