

Introduction

The *Information System in Addictions* (ISA) is a comprehensive system for monitoring the situation in the field of substance use and behavioural addictions in the Czech Republic. Previously, the system was referred to as the *Drug Information System* (DIS), as it had historically focused solely on the area of addictive substances and, above all, illicit drugs. Since 2019, when the *National Strategy for Prevention and Reduction of Harm Related to Addictive Behaviour 2019-2027* (National Strategy 2019-2027) explicitly integrated all addiction topics, i.e. alcohol, tobacco, illicit drugs, psychoactive medicines, gambling and digital addictions, the monitoring area has also expanded.

The monitoring is an indispensable component of the National Strategy 2019-2027 as well as the follow-up three-year action plans for implementation of the strategy. The current *Action Plan on Addiction Policy 2023–2025*, approved by the Government of the Czech Republic on 5 April 2023 by resolution no. 230, also highlights the need to ensure systematic and continuous monitoring of the situation across the full spectrum of addictions, i.e. the need to monitor the extent of substance use and other forms of risk behaviour in the population, including its health and social impacts.

The National Action Plan of the Information System in Addictions (NAPISA) is formulated as a tool to plan and frame ISA evaluations, succeeding the National Action Plans of the Drug Information System (NAPDIS) over past periods.

It is co-ordinated and guaranteed by the National Monitoring Centre for Drugs and Addiction (NMC), established by government resolution no. 643 of 19 June 2002 in the Secretariat of the Council of the Government for Drug Policy Coordination (renamed by resolution no. 412 of the Government of the Czech Republic of 18 May 2022 to the Council of the Government for Addiction Policy Coordination), which is an organisational part of the Office of the Government of the Czech Republic and its activities are laid down in the statute of the Government Council.


The National Monitoring Centre for Drugs and Addiction is the Czech national partner of the European Union's decentralised drugs monitoring agency, the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA), based in Lisbon, within the meaning of Article 5 of Regulation (EC) No 1920/2006 of the European Parliament and of the Council of 12 December 2006, and Article 12 of Regulation (EU) 2023/1322 of the European Parliament and of the Council of 27 June 2023 on the European Union Drugs Agency (EUDA).

Since 2002, an annual report on the state of drugs in the Czech Republic, and since 2015 an annual report on gambling in the Czech Republic have been presented to the Government. The areas of alcohol, tobacco, psychoactive medicines and excessive use of new technologies have not been systematically monitored and evaluated over the long term.

As of 2021, the NMC handles a decision of the Government of the Czech Republic no. 650 of 19 July 2021 specific thematic reports focusing on each addiction area, namely:

- Report on Tobacco and Nicotine Products in the Czech Republic,
- > Report on Alcohol in the Czech Republic,
- > Report on the Problematic Use of Psychoactive Medicines in the Czech Republic,
- > Report on Illicit Drugs in the Czech Republic,
- Report on Gambling in the Czech Republic and
- Report on Digital Addictions in the Czech Republic.

The thematic reports are followed by the *Summary Report on Addictions in the Czech Republic*. All reports are available at www.drogy-info.cz.



1 Evaluation of NAPISA 2020-2022

In 2023, the *National Action Plan on Information System in Addictions 2020-2022* (NAPISA 2020-2022) was evaluated. One of the main objectives of NAPISA 2020-2022 was to design systemic changes in monitoring to reinforce monitoring in those areas of the integrated addiction policy which have long been neglected, and to set up a comprehensive approach to monitor the scale of these phenomena and their public health effects, i.e. tobacco, nicotine and related products, alcohol, psychoactive medicines and behavioural addictions, including the issue of excessive use of digital technologies.

1.1 Assessment of NAPISA Objectives for 2020-2022

Objectives

A comprehensive overview of the situation regarding both licit and illicit addictive substances and behavioural addictions in the Czech Republic.

Evaluation

Achieved.

In 2021, in line with the new concept of the Report Package in the Field of Addictions, approved by the Government of the CR by Resolution no. 650 of 19 July 2021, thematic reports focusing on other areas of addictions were prepared and published, namely:

- Report on Tobacco, Nicotine and Related Products in the Czech Republic 2021,
- Report on Alcohol in the Czech Republic 2021,
- Report on the Problematic Use of Psychoactive Medicines in the Czech Republic 2021,
- The Report on Illicit Drugs in the Czech Republic 2021.
- > Report on Gambling in the Czech Republic 2021.

The thematic reports were followed by the *Summary Report on Addictions in the Czech Republic 2021*, approved by the Government of the Czech Republic on 6 April 2022. In July 2022, the abovementioned thematic reports were complemented by the *Report on Digital Addictions in the Czech Republic 2022* and later by the *Report on Illicit Drugs in the Czech Republic 2022* in November 2022.

A Summary Report on Addictions in the Czech Republic 2022 was then prepared and discussed by the Government of the Czech Republic on 12 April 2023.

Regular reporting and dissemination of information on the situation regarding both licit and illicit drugs and behavioural addictions in the Czech Republic.

Achieved.

In 2021 and 2022, the NMC delivered comprehensive reports on the addiction situation as well as detailed reports per thematic area. Other reports, based on thematic analyses or summarising the results of main studies and surveys (e.g. National Survey on Substance Use, NAUTA study, ESPAD, HBSC), are published by the institutions coordinating the data collection for each

population group and the EMCDDA European Drug Report is presented annually.

Ad-hoc analyses are performed and published when required. The results and analyses of different aspects of the drug situation are regularly published in the outputs and publications of a number of ISA institutions.

The periodical bulletin is published by NMC called Focused (previously Focused on Drugs), as well as Addictology in Prevention and Treatment practice (aplp.cz), Addictology journal (adiktology-journal.eu), which are directly focused on addiction issues, and other specific periodically published journals covering the wider areas of prevention, treatment and psychiatry.

The information is published continuously via the website <u>drogy-info.cz</u>, <u>szu.gov.cz</u>, <u>uzis.cz</u>, <u>adiktologie.cz</u>, <u>nudz.cz</u>.

The NMC is part of the European Reitox network. Data for the Czech Republic are reported annually to the EMCDDA and UNODC as requested by these institutions.

 Ensuring comprehensive monitoring in the area of tobacco and alcohol in the Czech Republic.

Achieved.

In 2021, the NMC prepared thematic reports summarising the state of tobacco use and alcohol consumption, health and social impacts and context. From 2023 onwards, the information package for the annual reports on addiction will contain 6 thematic reports each year, supplemented by the *Summary Report on Addictions in the Czech Republic*.

The new package includes:

- > Report on Tobacco, Nicotine and Related Products in the Czech Republic.
- Report on Alcohol in the Czech Republic.
- Introducing comprehensive digital addiction monitoring in the Czech Republic with focus on digital games, internet, social networks.

In 2022, the NMS prepared the first *Report on Digital Addictions in the Czech Republic*, which summarises the extent of the phenomenon in the Czech Republic and its health and social impacts and context.

 Establish a comprehensive monitoring for psychoactive medicines abuse/problematic use, particularly for sedatives and hypnotics.

Achieved.

In 2021, the NMS prepared a thematic *Report on the Problematic Use of Psychoactive Medicines in the Czech Republic*, which summarises the extent of the phenomenon in the Czech Republic and its health and social impacts and context.



2 NAPISA Objectives and Priorities for 2024-2026

2.1 Objectives of NAPISA for 2024-2026

The objective of the *National Action Plan of the Information System in Addictions 2024-2026* is to strengthen the monitoring system in the field of addictions, including tracking current trends and potential threats in the field of addiction and promoting a proactive approach to enhance preparedness for the future evolution of the situation in the field of addiction and policy in this area.

2.1.1 NAPISA Specific Objectives for 2024-2026

The specific objectives of the *National Action Plan of the Information System in Addictions* 2024-2026 include:

- > Comprehensive and regular monitoring of the situation regarding licit and illicit addictive substances, i.e. tobacco and nicotine products, alcohol, psychoactive medicines, illicit drugs and other substances with addictive potential.
- > Comprehensive and regular monitoring of the situation of behavioural addiction in the Czech Republic, i.e. gambling and excessive use of digital technologies.
- > Defining key indicators for situation monitoring in all areas mentioned which allow a comparison of the extent of individual phenomena and their impacts in the population.
- > Set up the monitoring system that is able to recognise and respond flexibly to new trends and phenomena, as well as to the demands of the evaluation of the effects of policies on the situation in addiction.
- Extending the scope of monitoring to activities and approaches stemming from the expanded mandate of the EU Drugs Agency (formerly the European Monitoring Centre for Drugs and Drug Addiction or EMCDDA), including monitoring polyvalent drug use, use foresight approaches and methods and collecting and analysing best practice approaches in addiction policy.

2.1.2 NAPISA 2024-2026 Tools

The main tools by which the objectives of NAPISA 2024-2026 should be achieved are:

- Regular reporting on the use and impact of both licit and illicit drugs and of behavioural addictions in the Czech Republic, and the distribution of information outputs;
- > An ensured staff capacity for a functional and sustainable situation monitoring system;
- Mutual cooperation between the different actors in the field of monitoring and data sharing;
- > Regular liaison with international organisations and participation in international projects in the field of monitoring addiction situations.
- > Continuous support of the competences and expertise of the monitoring system to analyse new trends and threats in the area of addiction.

2.1.3 Priority Topics of Monitoring in the Field of Addiction

The information system in addictions will continue to focus on monitoring the substance use and behavioural addiction domain across the whole spectrum, i.e. prevalences of individual phenomena and patterns of use/behaviours, as well as assessments of the health and social impacts. In addition to the routine data collection on situations and trends, it will also focus on collecting data on prevention, harm reduction, treatment and (re)integration interventions and strategies. For the period of 2024-2026, priority will be given to the following areas:

- > Cannabis and cannabinoids the prevalence and patterns of use of traditional cannabis products as well as new cannabinoids, use of cannabis products in treatment and self-medication, health and social effects of cannabis use (including HHC, CBD, etc.).
- > Psychedelics the prevalence and patterns of use of substances with psychedelic effect, their health and social impacts and the possibilities of use of psychedelics in the therapeutic context of psychiatric diseases.
- > Kratom and other new (so-called 'psychomodulatory') substances the prevalence and patterns of use of psychomodulatory substances, their health and social impacts.
- > New synthetic opioids and benzodiazepines the prevalence and patterns of use of new synthetic opioids, health and social impacts, specific target groups.
- > Polydrug use the combination of use of different addictive substances and its health and social impacts, including psychiatric comorbidities, and the effects of polydrug use on the system of treatment and care in the field of addiction.
- > Online gambling gambling in the online environment, its consequences and context.
- > Digital addictions prevalence and patterns of excessive use of digital technologies, its health and social consequences and correlates, and trends in number of clients entering treatment and addiction services with excessive gaming problem or excessive use of social media.
- > The impact of changes in the regulatory framework in the area of addiction policy on substance use prevalence and patterns, and the extent of negative health and social consequences of substance use (e.g. impacts of cannabis regulation, regulation of so called psychomodulatory substances).
- > Analysis of social costs related to substance use and other forms of addictive behaviour.

2.2 Institutions Involved in the Implementation of Information System in Addictions

The information system in addictions is co-ordinated by the National Monitoring Centre for Drugs and Addiction (NMC). In addition, the following institutions, in particular, are involved (in alphabetical order) in the collection and analysis of ISA data collection:

- > Association of the Regions of the Czech Republic,
- > the Association of Providers of Addiction Services (APAS),
- > Czech Association of Addictologists (professionals working in addiction field) (CAA)
- Czech Medical Society of Jan Evangelista Purkyně (Society for Addictive Diseases SAD CMS JEP, Society of Forensic Medicine and Forensic Toxicology - SFMFT CMS JEP)
- The Czech Statistical Office (CZSO),

- > The Directorate General for Customs (Customs Service), in particular the Customs Drugs Unit (CPJ)
- Directorate General of the Prison Services (Prison Service),
- Institute for Criminology and Social Prevention (ICSP),
- Department of Addictology of 1st Faculty of Medicine, Charles University and General Teaching Hospital in Prague (Department of Addictology),
- > regions, through regional drug coordinators and local drug coordinators,
- > Institute of Criminology in Prague,
- > ministries (ministry of health, ministry of labour and social affairs, ministry of education, ministry of defence, ministry of finance, ministry of international affairs, ministry of agriculture, ministry of industry and trade, ministry of transport) and their departments and organisations,
- > National Institute of Mental Health (NIMH),
- > The Police of the Czech Republic (Police Czech Republic), in particular the National Drug Squad of the Criminal Police and Investigation Service (NDS) and the Police Presidium of the Czech Republic,
- > Probation and Mediation Service (PMS),
- > State Institute for Drug Control (SIDC),
- National Institute of Public Health (NIPH),
- > the Federation of Towns and Municipalities of the Czech Republic,
- > universities across the Czech Republic,
- Institute for Health Information and Statistics (IHIS).

The above list does not have to include all institutions and organisations involved in the collection, analysis and distribution of information in the ISA; other institutions, bodies and organisations in the Czech Republic are also involved in the same intensity and at different intervals.

2.3 Horizontal Cooperation under ISA

2.3.1 NMC Working Groups

Actors of NMC expert working groups co-operate on the various themes of the information system in addictions.

A priority in this area is the revision of the current system of working groups and membership in these groups. The Working Groups will be established on an ad-hoc basis on specific themes to ensure that their work in the future is clear, effective and well-resourced in terms of coordination and cooperation between departments and institutions in the different areas.

2.3.2 Advisory Board for Data Collection in Addictions

The Advisory Board for Data Collection in Addictions (Advisory Board) is an advisory committee of the Council of the Government for the Coordination of Addiction Policy. The Advisory Board discusses NAPISA and assesses its implementation during the previous period, discusses the

individual thematic reports of the addiction situation before their submission to the Council, and the Summary Report on Addictions before its submission to the Council and subsequently to the Government of the Czech Republic, and discusses other outputs of the NMC.

A priority in this area is to revise the membership of this Advisory Board, in particular to broaden the scope of situation monitoring to include new topics and phenomena, such as monitoring the situation of tobacco and nicotine products, alcohol, psychoactive medicines and digital addictions.

2.4 NAPIZA Activities for the Period 2024-2026

2.4.1 Monitoring and Data Collection on Key Indicators of the Extent of Phenomena in the General Population and Their Public-Health Impacts

Different organisations and institutions collect a wide range of information on a continuous or periodic basis. This includes data on substance use, gambling and digital addictions in the population, as well as their health and social impacts. Information on interventions provided are also recorded, including prevention activities, harm reduction interventions and treatment programmes. Furthermore, data are collected on substance-related criminality and other relevant information within the realm of drug supply reduction, including seizures, prices and purity of drugs and the market for licit addictive substances.

- > A priority in this area is the definition of key indicators of monitoring the situation in all of these areas (substance use as well as the behavioural addictions) to allow a comparison of the extent of individual phenomena and their impacts in the population.
- > Extending the collection of information on poly-substance use, the emergence of new psychoactive substances and the collection of additional data as requested by EUDA.
- > The design of tool for identification of expenditures on different addiction policy topics, to track the level of funding spent on both substance and behavioural addictions.

2.4.4 Distribution of Information

The main outputs of the *Information System in Addictions* (ISA) are reports on the addiction situation that are processed by NMC based on the information provided by the other ISA actors, as well as from its own studies and data analysis. As of 2021, the NMS produces, based on the decision of the Government of the Czech Republic no. 650 of 19 July 2021, specific thematic reports in the field of addictions, including:

- > Report on Tobacco and Nicotine Products in the Czech Republic,
- > Report on Alcohol in the Czech Republic,
- > Report on Problematic Use of Psychoactive Medicines in the Czech Republic,
- > Report on Illicit Drugs in the Czech Republic,
- > Report on Gambling in the Czech Republic and
- > Report on Digital Addictions in the Czech Republic.

The thematic reports are followed by the Summary Report on Addictions in the Czech Republic.

The basic structure of the individual thematic reports is the same so that the extent and impact of the phenomena can be compared across the selected indicators. All reports are available under the Reports section of the website: https://www.drogy-info.cz/publikace/vyrocni-zpravy/.

NMC publishes series of publications in four editing series (Monographs, Methodology, Research Reports, Coordination) and the Focus Bulletin (starting from 2023, these are two issues per year, originally six issues per year). A list of all publications with the ISBN that have been published so far and all serial numbers in the Focus serial are published on the website: https://www.drogy-info.cz/publikace/seznam-publikaci/.

The NMC maintains 4 websites: drogy-info.cz focused on illicit drugs, providing information about the activities of the NMC with the full scope of its activities and the thematic pages dedicated to the general public: alcohol-skodi.cz focused on the harmful use of alcohol, koureni-zabji.cz focused on the field of tobacco and nicotine products and hazardni-hrani.cz focused on gambling. In addition, NMS shares information via two social media sites: https://www.facebook.com/drogyinfo and https://www.facebook.com/vyzkumdrogyinfo.

A priority in this area is to revise the existing information distribution system through a broader spectrum of outputs targeted at different target groups, to share updates via websites and social networks, and to streamline the distribution of information on publication outputs and NMC activities to the professional public.

2.4.5 Coordination of the Early Warning System on New Synthetic Drugs (EWS)

As a specific information system aiming at exchanging quick information and alerts about severe acute risks from dangerous substances on the drug market, NMC has been coordinating the Early Warning System for New Synthetic Drugs (EWS). The working group gathers and evaluates data on the production, distribution and use of new psychoactive substances in the Czech Republic and ensures quick exchange of information both nationally and internationally. The EWS aims to share information as early as possible on the occurrence and use of new psychoactive substances in the Czech Republic and cooperation within the EU Early Warning System on drugs under Council Decision 2005/387/JHA. It assesses new substances proposed in the Czech Republic for inclusion in the list of illicit psychoactive substances.

A priority in this area is in line with the EMCDDA's transformation into a newly established EU Drugs Agency (EUDA), and the extension of the scope of the European Early Warning System on new synthetic drugs (NPS) for other substances, as well as active engagement in the emerging European Drug Alert System (EDAS), which aims to exchange information and handle alerts on serious risks from dangerous substances on the drug market.

2.5 Engagement in International Activities and Projects

The NMC is part of the European Reitox network of national focal points and the partner of the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA)/EU Drugs Agency (EUDA) for the collection, analysis and reporting of data for the Czech Republic to the European system (emcdda.europa.eu/about en). The NMC is a key partner for the EMCDDA/EUDA, especially in the collection of up-to-date information about new trends and phenomena in the field of drug use and its implications, as well as the annual processing of reports to the European system regarding the situation in the Czech Republic, through a set of statistical tables and structured questionnaires, thematic structured reports and ad hoc reports and information on specific topics as requested by the EMCDDA/EUDA.


At international level, NMC also provides outputs on behalf of the Czech Republic for other international organisations (e.g. United Nations Office on Drugs and Crime, UNODC) through annual reporting via online questionnaires (ARQs).

NMC is actively involved in one-off and long-term European projects and studies – it coordinates the Czech part of the European School Survey Project on Alcohol and Other Drugs (ESPAD) and the European Online Drug Study (EWSD), participates in the DRUG-PREP project to increase preparedness of monitoring systems to emerging trends and potential threats, and in the Council of Europe's coordinated Pompidou Group for online gambling and gaming.

> The priorities in this area are in line with the EMCDDA's transformation into a newly established EU Drugs Agency (EUDA), including expanding the scope of European monitoring by bringing new topics of active involvement in EUDA's work and deepening cooperation at horizontal level with monitoring centres in other European countries. New EUDA topics include e.g. polysubstance use and its impacts, trends in and impacts of using a wider range of cannabis products, and the use of substances with a psychoactive effect in the medical context.

2.6 Evaluation of NAPISA 2024-2026

The implementation of the *National Action Plan of the Information System in Addictions 2024-2026* will be evaluated after the expiration of the NAPISA. The evaluation of NAPISA 2024-2026 will be presented together with the planning for the next period to the Advisory Board on Data Collection in Addictions and then to the Council of the Government for Addiction Policy Coordination.
